

Vicars, William Walker, William Harryson, John Pasty, John Hurst, Richard Cowper, William Madder, John Newbold, John Elyson, Richard Cowper, William Kyngs: no pension being allowed to any of them.

"After which, this House, with all that belonged thereunto, excepting the rent of 20*s.* per annum due to Mereton's chantry before mentioned, was, among other things, by the King's letters patents, dated August 17th, 36th Hen. VIII., granted to Sir Ralph Sadler and his heirs, to hold in bur-gage; which Sir Ralph sold it to John Hales,<sup>a</sup> who made it his habitation as it seems; for by his will and testament, dated Decemb. 17th, 15 Eliz., appointing it to be sold, he there calls it by the name of Hales'-place, alias White Friars, Coventry.

"But notwithstanding the before specified appointment, it was not accordingly sold; for John Hales, Esq., descended from Christopher, his eldest brother, now enjoys it as his heir. At the death of the before specified John, the Church was completely standing, as appears by that Inquisition, but it continued not long after, for about . . . Eliz. Mr. Edward Boughton, obtaining the materials, built his House at Causton therewith."<sup>b</sup>

ROBERT was Prior of this Friary in 1392. WILLIAM, 5th Hen. V. ROBERT, 1459. THOMAS, 1497, and 1504.<sup>c</sup>

### WARWICK.

"A HOUSE of White Friars here is said to have been built by John Peyto, junior, about 18 Edw. III., Thomas Beauchamp Earl of Warwick giving the ground whereon it was situated. And in Mr. Le Neve's abstract of the patents, the House is said to have been granted, 4th Edw. VI., to John Earl of Warwick. But, *Quære*; for I find not the least mention of it in Dugdale."

Such is Tanner's Account, who adds, "*Vide* Collect. magistri Stow penes Jo Anstis arm. ex record. 18 Edw. III."

### APPLEBY, in WESTMORELAND.

In this town was a House of White Friars, said to have been founded by the Lord Vesey, Lord Percy, and Lord Clifford, A. D. 1281.<sup>d</sup> After the Dissolution it was granted to Christopher Crakenthorp, 35th Hen. VIII.<sup>e</sup>

### MARLEBURGH, or MARLBOROUGH, in WILTSHIRE.

ON the South, side of the street in this Town, says Tanner, was a House of White Friars,<sup>f</sup> founded by John Goodwin and William Remesbesch, merchants,<sup>g</sup> A. D. 1316,<sup>h</sup> which was granted to John Pye and Robert Brown, 34th Hen. VIIIth.<sup>i</sup>

### NORTH ALLERTON, in YORKSHIRE.

ROGER GALE, in his Account of North Allerton, says, "I found but one Religious House here, which was of Carmelites: the Site of it was on the east side of the Town, on the bank of the little brook called Sunbeck, and still retains the name of the Freerage: nothing remains of it but some foundations of the out-walls that encompassed it. It was founded by Thomas Hatfield bishop of Durham, who died in 1381, after he had sat in that see almost thirty-six years.

Being of a mendicant order, it had no possessions beside the House and Gardens, which now belong to Robert Raikes, Esq., and lie on the back side of his dwelling-house. Walter Kellaw, prior of this Convent, was Provincial of the Carmelites in England, died and was buried here, A. D. 1367, so perhaps was the first Prior.<sup>k</sup>

Speed ascribes this Foundation to King Edward the Third and Bishop Hatfield. Tanner thinks it was founded about 1354, when it was dedicated to the Virgin Mary.

The Surrender, sealed with the Conventual Seal, is in the Augmentation Office.

### BOLTON, in YORKSHIRE.

THE following is Tanner's mention of this House. "Here was a House of Carmelite Friars founded by the Earl of Albemarle, or, as others, by Lord Gray of Codnor, saith Mr. Speed. But he is certainly mistaken in making these Mendicants to have been endowed with 102*l.* 9*s.* 3*d.* per annum." He adds, "*Vide* Lelandi Collect. tom. i. p. 54. Pat. 9 Edw. III. p. 2."

### DONCASTER, in YORKSHIRE.

LELAND says, "There was a right goodly House of White Freres in the mydle of the Town now defacid." Itin. vol. i. p. 36. See also MS. Cole, vol. xxvi. fol. 101 b.

### KINGSTON UPON HULL.

LELAND says, "The White Freres College" here "stood by Beverlegate. The Percys were taken for founders of it."<sup>l</sup> But Speed says it was founded by King Edward the First,<sup>m</sup> Sir Robert Oughtred, and Richard de la Poole, 13th Edw. I. Tanner refers relating to it to "Cart. 33 Edw. I. n. 73. pro tribus acris in Milncroft extra villam datis per regem. Pat. 13 Edw. II. m. 5 vel 6, et m. 15. pro manso elargando."<sup>n</sup> John Thurscrose did homage, 32 Hen. VIIIth, for the Site of this House,<sup>o</sup> which was granted 28th July that year to John Heneage.<sup>p</sup>

### PONTEFRACT, in YORKSHIRE.

EDMUND LACY Earl of Lincoln, who died about A. D. 1257, is stated by Leland in his Itinerary to have been the founder of the House of White Friars at Pontefract.<sup>q</sup>

### RICHMOND, in YORKSHIRE.

TANNER says, "On the patent Rolls, 15 Eliz., is a grant of the House of the White Friars here to Thomas Wray and Nicholas Medcalf. But I suspect there is some mistake in it; for the exact Mr. Gale, in his Appendix to the Register of the honour of Richmond, takes no notice of any White Friars here, nor have I met with any account of such in this place elsewhere." Clarkson, who has written the History of Richmond at considerable length, is also silent as to any such foundation.

### SCARDEBURGH, or SCARBOROUGH, in YORKSHIRE.

A HOUSE of Carmelite Friars here is said to have been founded by King Edward the Second, A. D. 1319.<sup>r</sup>
