IN the Deanery of Holderness and Archdeaconry of East Riding. Here, says Tanner, seems to have been a House of White Friars, *temp.* Edw. I. *Vide* Pat. 34 Edw. I. m. . pro fratribus Carmelitis de Sutton.^a

YORK.

THE Convent of Carmelites or White Friars of York was fixed in that city A. D. 1255 by Lord Vescy and Lord Percy.^b Leland says, it was situated not far from Laythorp gate.^c Upon the Suppression this House was granted to Ambrose Beckwith, 35th Hen. VIIIth.

The SEAL is engraved in Drake's York.

LELAND in his Itinerary, vol. iii. p. 135, says, "A Priest of Saresbyri told me that ther was an House or Celle of Bonhomes at Ruthin by Denbigh Land, and that sins it was translaid into a Paroche Chirch. I toke this knowlege that ther had bene an House of one of the Fouere Orders of Mendicants." In another part of his Itinerary, vol. v. p. 45, he says, "There were ons White Freres at Rithyn yn Diffrin Cluit."

CARDIFF, *in* GLAMORGANSHIRE.

HERE also is said to have been a House of White Friars.^d It was probably destroyed by Owen Glyndowr.
